### Session 1: S.B. 12 Age Limit for Tobacco and Related Products

### **Session II. Medicaid Expansion**

Representative Marie Poulson (D) District 46 spoke on the people without qualifying insurance who needed the help the Medicaid expansion would provide. She also answered questions on the limitations when expecting charity to pay for health care, citing that while charities may be counted on for a first doctor visit, there are no funds for subsequent surgery, radiation, chemo, medications, etc.

Derek Monson, Directory of Policy, Sutherland Institute spoke on negative costs from Medicaid Expansion.

Raylee Curtis, Medicaid Policy Analyst spoke on the Medicaid Expansion with illustrated charts showing the savings over several years which better care now would ensure.

Senator Allen Christensen ® District 19, spoke against the Medicaid Expansion citing government contributions to the program were dubious.
